The ICEJ'23 aims to bring together research scholars working in the area of Environmental Justice. The purpose of the Conference is to encourage young research scholars to present their research before a panel of academic experts and to receive valuable feedback for further research. Furthermore, this Conference seeks to build fruitful research collaborations among institutions across the world.

This Conference is facilitated by the European Union funded Support to Justice Sector Project (JURE), UNDP's flagship initiative, jointly implemented with the Ministry of Justice and UNICEF Sri Lanka.

#### CALL FOR PAPERS

The Conference welcomes submissions by **postgraduate students and early career researchers from any disciplinary field across the world**. In the case of co-authors, at least one of the authors must be a current postgraduate student or an early-stage career academic.

The thematic areas of the Conference will be centred around issues of Environmental Justice. The acceptance of abstracts will depend on the relevance of the issues raised by the conference panels and the originality of the research after being screened by a panel of reviewers. The abstracts

selected by the reviewers will be invited for a full paper presentation at the Conference. The selected authors at the Conference will be offered the possibility to publish their paper in a special journal publication, subject to a careful selection following editorial and peer reviews.

# **GUIDELINES FOR ABSTRACT SUBMISSION**

- 1. Please note that the number of selected abstracts for presentation in the final Conference is strictly limited to 60 abstracts.
- 2. Authors should write an **abstract between 250 to 300 words** relating to the themes of the Conference.
- 3. The abstract should include a suitable title for the paper, three to five keywords, the name of the author(s), and their affiliation.
- 4. The abstract should be coherent and free of grammatical errors.
- 5. Selected abstracts are published for the conference proceedings.

#### **GUIDELINES FOR FULL PAPER SUBMISSION**

- 1. The main text of the full paper should be written in Times New Roman font size 12, with 1.5 line spacing, and footnotes in Times New Roman font size 10, with line spacing 1.0.
- 2. All the headings should be numbered and written in 12-points. Each main heading (first level) should be capitalised, bold, and centre-aligned. The second-level heading should be in title case, bold, and left-aligned. The third level heading should be in title case and left-aligned.
- 3. Authors should follow the **APA Style** mode of citation throughout the paper.
- 4. The word limit for the full papers should remain **between 5000-8000 words**, including footnotes (excluding abstract and bibliography).
- 5. All the authors shall give an undertaking that the plagiarism of the paper is below the permissible limit of 15%.
- 6. Research should be an original work of the author and must not have been submitted or accepted for publication.
- 7. Authors should strictly adhere to the following formatting guidelines:
  - ❖ Do not use abbreviations without prior explaining the terms.
  - ❖ Do not use bold and/or underline to highlight the text.
  - ❖ Use single quotes to emphasise a word or phrase.
  - ❖ Tables and charts should be centre-aligned if used.

It owes its origin to NAPSIPAG researchers in Law & Governance who discovered the need for transdisciplinary interaction with practitioners in law-administration-natural sciences-egovernance and Artificial Intelligence to prevent and mitigate disasters. Disasters have become too frequent and more devastating with a gruelling dent in the GDP of Asia Pacific countries. India, Bangladesh and Pakistan alone combine to show the highest mortality risk index (MRI) but this is also a region where almost 40% of the world's poor are located in subsistence economy in fragile zones. Disasters are more an issue of development, livelihood and sustainable socio-economic prosperity. The immediate catalyst to bring disaster managers together was the NAPSIPAG's International Conference at Doiwala in Dehradun June 20-22, 2013 at the EcoAshram of legendary environmental lawyer Shri.M.C.Mehta. The timing of this meet on 'How Much Land Does a Man Need' was on land mismanagement and human greed as a cause for environmental distress and disasters. This discourse providentially coincided with the devastating and ruinous Uttarakhand floods. The spectre of death as humans and nonhumans succumbed to a furious and anguished nature in the rapids of the holy river Ganges called for revisiting laws and institutions which failed humanity. The congregating experts from all over Asia-Pacific vouched for an intensive research, training, education and dissemination in disaster studies as an indispensable pathway to sustainable development.

#### Department of Political and Social Sciences, University of Catania, Italy

# CAPAZ German-Colombian Peace Institute & Chair for Peace Studies, Justus-Liebig University Giessen, Germany

Founded in 1607, Justus Liebig University Giessen (JLU) is a long-established research university that attracts around 28,000 students. In addition to a broad range of courses - from the natural sciences to law and economics, social and educational sciences, and linguistic and cultural studies - it offers a spectrum of life sciences. The Chair of Peace Studies is concerned with the scientific analysis of peace processes and conflicts as well as with North-South relations and development policy issues. The focus of the work at the Chair is on the Global South and in particular Latin America. The Professorship is also the founding Chair of the German-Colombian Peace Institute - Instituto Colombo-Alemán para la Paz (CAPAZ) based in Bogotá/Colombia. Consequently, the scientific support of the Colombian peace process is the focus of current work in research, teaching and knowledge transfer of the department. The joint research project NISANSA complements climate change research with regional and social science perspectives, focusing on the Global South. Within this project, the Chair for Peace Studies focuses on the extractivist dynamics related to the energy transition and climate change. Large parts of the Global South are characterized by commodity dependencies and can be described as extractivist or rentier societies. The fact that a successful energy transition for the Global North and progress in international environmental and climate policy would undermine the economic, social and political structures, especially of such extraction societies that are heavily dependent on fossil fuels, and would harbor conflict potential, has hardly been discussed so far. This raises questions about the scope of so-called "just transition" in countries dependent on the export of primary fossil commodities. To date, economic diversification strategies have been seen as the silver bullet for adapting to projected declines in demand for oil or coal. In the past, such strategies have been pursued with great vigor, but with little tangible success. The reasons for repeated failures are too often attributed solely to policy failures. In contrast, this research project aims to examine the economic, social, political, and sociocultural persistence of the extractivist model of development at the local level in order to develop alternative pathways to a postfossil future.

# City University of New York, United States
